# THE NUS MSc IN FINANCE

The **Master of Science in Finance** programme is tailored to equip graduates with the tools and insights needed to navigate the evolving landscape of the financial industry. It uses self-directed and experiential learning to build your foundational finance knowledge while fostering resourcefulness and enterprise in finding effective solutions. You are expected to complete 48 units over three semesters.

### FIRST SEMESTER

Aug - Nov | On Campus (12 Units)

Students will take 4 courses in the first semester:

- Accounting for Financial Professionals
- Financial Modelling
- Introduction to Finance
- Statistics and Analytics in Finance

### SECOND SEMESTER

Jan - Apr | On Campus (16 Units)

Students will take 4 courses in the second semester:

- Applied Corporate Finance
- Foundation of Investments
- International Finance and Economics
- Options and Fixed Income

### EXPERIENTIAL LEARNING

May - Jul | Optional (2 - 4 Units)

Through an Industry Internship, a Corporate Consultancy Project, or a Faculty Research Project, you will develop analytical and problem-solving skills while working collaboratively. These experiences also help you understand how your actions impact your colleagues and company.

### THIRD SEMESTER

Aug - Nov | On Campus (16 - 20 Units)

- Finance and Technology
- Investment Finance
